With the Building Products (Safety) Act Part 2A set to come into effect in 2025, everyone in the Building Product supply chain—including wholesalers, suppliers, importers, and distributors—will have new responsibilities. - Product Technical Statements (PTS): Each product must have a PTS that moves along the supply chain, detailing compliance and safety.
- Local Accountability: If dealing with overseas manufacturers, the responsibility falls on you as the local link in the chain.
